E. Travel Allowance

The gross rates are inclusive of travel time in the inner and metropolitan suburbs.

For outer suburbs and locations not serviced by public transportation, mileage (0.80\$/km) of travel allowance may apply.

F. Cancellation policy

- 1. Assignments cancelled by the customer on the day, or after 3 PM on the preceding day, interpreters will be paid 100% cancellation fees.
- 2. Assignments cancelled by the customer between 12 PM and 3 PM on the preceding day, interpreters will be paid 50% cancellation fees.
- 3. Assignments cancelled by the customer before 12 PM on the preceding day, interpreters will not be paid cancellation Fees
- 4. Cancellation fees do not apply when a job is cancelled and replaced by a new job number in the following circumstances:
- (4.1) the assignment time is amended to a new start time, but still overlaps with the original booking time.
- (4.2) the assignment duration is changed, or
- (4.3) the assignment location is changed but remains within the same suburb/area of the original booking.

Please note that in the case of (4.1) and (4.2) the amended job is adjusted under the original booking's reference number. The interpreter allocated to the merged jobs is paid from the new start time to the new finishing time.

G. Dismission policy

If you are allocated for an onsite job and you are dismissed without being required to deliver the job, you must:

- Call Onspot's office and seek instructions from the interpreters' coordinator.
- Wait at the job location and do not leave unless dismissed by Onspot officially.
- Often, the individuals dismissing at the onsite job are different from the clients who originally made the booking. Therefore, Onspot must contact the client immediately and seek final instructions from them. The interpreters' coordinator will get back to you as Soon as possible.

I. Payment procedures

- 1. All Onspot members are contractors, and their payment is processed into the payroll system.
- 2. Payments are paid on a monthly basis and will be processed on the 16th of the month into the members bank account. You will receive from Onspot two emails:

- 1.1) A summary of Bookings, which includes details of all types of services completed by our member panels during the previous month, and the gross payment.
- 1.2) A Payslip that outlines members total Gross pay, tax deduction and superannuation contribution.

3. Income Statement

- 3.1) All gross rates are rounded up or down to the nearest dollar.
- 3.2) Income statement will be available in the Australian Taxation Office (ATO) online service. You can access it through myGov account.
- 3.4) As of 1 July 2022, contractors are eligible for super guarantee (SG) of 11% contributions of their total gross income, regardless of their earnings amount, because the \$450 eligibility threshold in a calendar month for when SG is paid is being waived. SG is to be paid quarterly.

4. Tax and Superannuation contribution:

- 4.1) Your tax is deducted from your monthly payment in accordance with your Tax file number (TFN) declaration form. Your income will be reported directly to the ATO, and the tax is sent to ATO monthly by using Single Touch Payroll (STP).
- 4.2) According to the law since 01/07/2013, Superannuation Guarantee levy is paid into your nominated Super Fund.
